RESOLUTION OF THE BOARD OF DIRECTORS OF THE SADDLE ROCK SOUTH METROPOLITAN DISTRICT NO. 4

AMENDING THE DISTRICT'S 24-HOUR POSTING LOCATION

WHEREAS, the Saddle Rock South Metropolitan District No. 4 (the "District") is a quasimunicipal corporation and political subdivision of the State of Colorado; and

WHEREAS, pursuant to §24-6-402(1)(a), C.R.S., the District is a local public body and subject to the provisions of §§24-6-401, et seq., C.R.S.; and

WHEREAS, pursuant to §32-1-903(2) and §24-6-402(2)(c), C.R.S., the District shall be considered to have given full and timely notice to the public if notice of the meeting is posted, with specific agenda information if available, on a public website of the District no less than twenty-four (24) hours prior to the meeting; and

WHEREAS, pursuant to §24-6-402(2)(c), C.R.S., the District shall make the notice posted on the public website accessible at no charge to the public, consider linking the notice to any appropriate social media accounts of the District, and, to the extent feasible, make the notices searchable by type of meeting, date of meeting, time of meeting, agenda contents, and any other category deemed appropriate by the District; and

WHEREAS, pursuant to §24-6-402(2)(c), C.R.S., the District shall designate a place within the boundaries of the local public body at which it may post a notice no less than twenty-four (24) hours in advance of the meeting in the event that the District is unable to post the notice online due to exigent or emergency circumstances; and

WHEREAS, the District approved Joint Resolution No. 2023-03-01 which designated the northwest corner of Gartrell Road and East Easter Avenue as the twenty-four hour posting location in the event that the District is unable to post notice on the District's website; and

WHEREAS, the District desires to revise the twenty-four hour posting location to better fit the needs of the community.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD AS FOLLOWS:

1. Pursuant to §24-6-402(2)(c), C.R.S., the Board hereby designates the following location for the posting of its meeting notices twenty-four (24) hours in advance in the event that the District is unable to post notice on the District's website:
